Magnolia Park Trail – The contractor continues to pump water out of the pond to allow access for construction equipment. Grading work continues.

Woodhurst – All the street pavement is complete with the exception of the stamped concrete at Heartz. Working on sidewalk construction, irrigation repairs, and final cleanup.

DART - Completed the sidewalk at the Southwestern crossing and getting

ready to pour the sidewalk at Coppell Rd West side.

Fire Station #5 – The contractor is going vertical this week with CMU and the steel starting.

Service Center – site work has started for the parking area and is expected to take 4-6 weeks.

Deforest Lift Station Site Improvements – Beginning the preparation for driveway repairs.

635/Belt Line U-Turn – TxDOT's contractor is finishing forming up bent caps for the new U-Turn bridge. Once the bent caps are in place, they will schedule the 30-days advance notice for a weekend full closure of IH 635 in order to place beams. TxDOT is targeting early December for the weekend full closure of IH 635 to place beams for the new U-turn bridge at S. Belt Line.
