2. Citizens' Appearance

Chair Singh advised that no one signed up to speak.

3. Approval of Minutes: April 9, 2026

A motion was made by Boardmember Radhakrishnan, seconded by Boardmember Pagedar, that this agenda item be approved. The motion was carried by a unanimous vote.

4. Youth Advisor's Report

Youth Advisor Ajani provided the Board with an update on their project and on behalf of Youth Advisor Chandrashekar. The teen event focusing on helping students with college applications and lifestyle advice has been scheduled to take place in September 2026. For social media, footage will be recorded to help promote events and activities occurring in the library. A flyer was created for Tutor.com to help promote the service. A suggestion was made by the Board to add a QR code that could be used to keep track of the users that access the service via the flyer.

5. Friends of Coppel Public Library Report

Boardmember Radhakrishnan provided an update to the Board regarding the Friends of the Friends of the Coppel Public Library.

The Friends will be participating in the Summer Reading Challenge Kickoff on May 30, 2026. The next Friends meeting will occur on May 18, 2026 in the Library. This is the annual meeting where officer elections will be included. The Annual Big Book Sale dates have been finalized. The sales will be conducted on the following dates and times:

- Thursday, November 5, 2026: 4:00 p.m. to 8:00 p.m.
- Friday, November 6, 2026: 1:00 p.m. to 5:00 p.m.
- Saturday, November 7, 2026: 10:00 a.m. to 4:00 p.m.
- Sunday, November 8, 2026: 12:00 p.m. to 4:00 p.m.

6. Manager's Report

Library Manager, Alexis Wellborn, reviewed statistics, programs and operations for the Library.

A candidate for the part-time library assistant has been selected and expected to start by the end of May once pre boarding requirements have been completed. As of May 4, 2026, the new reservation process has been implemented. Patrons must have a library card in good standing and may block 3-hours per session.

The Library, along with the rest of the city, will be phasing out the penny. Patrons will have the choice of paying with exact change or have their transaction rounded up to facilitate this change. CISD library cards will also be phasing out. This will include any student in CISD who does not reside in Coppel. On October 1, 2026, the cards will change over to a regular non-resident card. All patrons with this coding will be notified and will be able to purchase a non-resident card for the next school year if they so choose.
