Deputy City Manager Kent Collins reported on the following:

- 1) Vision 2040 Refresh We're excited to announce the launch of the Vision 2040 Refresh project, a citywide effort to gather community input and ensure that our long-term strategic plan continues to reflect community's the values, needs, and aspirations. - 2) DART Road Closures DART will close the rail crossings at Southwestern Boulevard and Moore Road next week. Southwestern Boulevard between S Coppell Road and Denton Tap Road will be fully closed from 7 am on Monday, July 28, through 7 pm on Tuesday, July 29. Moore Road between E Belt Line Road and Carter Drive will be fully closed from 7 am on Friday, August 1, through 7 pm on Saturday, August 2.

12. Mayor and Council Reports on Recent and Upcoming Events.

Mayor Wes Mays reported on the following items:

- 1) Open Doors at Life Safety Park: Join us Friday, July 25th, from 9-11am, at Life Safety Park located at 820 South Coppell Road. We'll be exploring the select parts of the facility with learning opportunities at each spot! We'll learn about the history of Coppell Fire Department, practice pedestrian safety, chat with a firefighter, and more! Registration is free and encouraged but not required.
- 2) Hygiene Donation Drive The Cozby Library is currently collecting hygiene items to benefit Metrocrest Services. These items help promote health, wellness, and empowerment to local families and seniors in crises.   - A. C/FBISD/LISD Liaison Councilmember Hill reported that LISD will report back to school on August 12. The district-wide Back to School Event will be held on July 29 at Hendrick Middle School. Finally, Councilmember Hill congratulated LISD's Superintendent Dr. Laurie Rapp for being named 2025 Region 11 Superintendent of the Year.
  - B. CISD Liaison Councilmember Nevels reported CISD will report back to school on August 13. Interim Superintendent Doug Williams and the Board of Trustees are working on a multi-year balanced budget plan to address the decline in enrollment numbers, sustain educational quality, and ensure financial health.

Finally, facility updates include: New Tech@Coppell is looking at two options moving forward a) to remain at the current location and expand open enrollment with a re-imagined model, or b) to relocate to the Coppell High School campus and re-imagine the model as a school-within-a-school model. Board action is expected August 11. The Board of Trustees is also offering upcoming community input meetings to discuss potential elementary campus consolidations.

Update will be July 23. The Seniors have also been enjoying the one Saturday per month opening and hope to see more dates offered in the future.
