A RESOLUTION OF THE CITY OF COPPELL, TEXAS, AMENDING RESOLUTION NO. 010996.3, THE MASTER FEE SCHEDULE, AS AMENDED, BY ADDING THE DONATION RECEPTACLES FINES, IN PART; AMENDING THE ROLLINGS OAKS MEMORIAL CEMETERY FEES, IN PART; ADDING FEES REGARDING THE VILLAGE COLLECTIVE; AMENDING PRESENTATION OF GENERAL FEES, COPPELL CITY CODE IN THE MASTER FEE SCHEDULE AND PROVIDING A REPEALING CLAUSE AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Coppell, Texas, previously adopted Resolution No. 010996.3 to provide for general and special fees and charges to be assessed and collected by the City, as authorized by the Code of Ordinances and other applicable codes, ordinances, resolutions, and laws; and

WHEREAS, the City Council of the City of Coppell desires to add and amend certain fees as set forth therein as authorized by law;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COPPELL, TEXAS:

SECTION 1. That the Master Fee Schedule section entitled “Donation Recetacles” be added, in part to read as follows:

Donation Receptacles (Effective June 1, 2025)

- Violation of ordinance fee – up to \$500/day
- Permit application fee - \$250
- Impounding hauling fee - \$200
- Daily impound storage fee - \$50

SECTION 2. That the Master Fee Schedule section entitled “Rolling Oaks Memorial Center Fees” be revised, in part to read as follows:

- Rather than residents receiving a 20% discount, there will now be a designated resident rate.
- Rather than being optional, proof of residency is now required.

SECTION 3. That the Master Fee Schedule section entitled “The Village Collective” be added, in part to read as follows:

- Annual membership dues: the annual membership rate is determined by the Community Development Director and is reassessed annually.
- Programming and Events: Fees for each event and program are to be based on actual cost to provide the event/program.
- Credit card processing fee: 3.40%

- Credit card transaction and processing charges: \$.30 and \$.50 per transaction.

SECTION 4. That all provisions of the resolutions of the City of Coppell, Texas, in conflict with the provisions of this Resolution, except as noted herein, be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this Resolution shall remain in full force and effect.

SECTION 5. That should any word, phrase, paragraph, or section of this Resolution be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this Resolution as a whole, or any part or provision thereof other than the part so decided to be unconstitutional, illegal or invalid, and shall not affect the validity of the Resolution as a whole.

SECTION 6. That this Resolution shall become effective immediately from and after its passage as the law and charter in such cases provide.
