**A RESOLUTION OF THE CITY OF COPPELL, TEXAS, AMENDING  
RESOLUTION NO. 010996.3, THE MASTER FEE SCHEDULE, AS  
AMENDED, BY AMENDING THE GARBAGE COLLECTION FEES, IN  
PART; AND PROVIDING A REPEALING CLAUSE AND PROVIDING  
AN EFFECTIVE DATE.**

**WHEREAS**, the City Council of the City of Coppell, Texas, previously adopted Resolution No. 010996.3 to provide for general and special fees and charges to be assessed and collected by the City, as authorized by the Code of Ordinances and other applicable codes, ordinances, resolutions, and laws; and

**WHEREAS**, the City Council of the City of Coppell desires to add and amend certain fees as set forth therein as authorized by law;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY  
OF COPPELL, TEXAS:**

**SECTION 1.** That the Master Fee Schedule section entitled “Garbage Collection Fees” be amended, in part to read as follows:
