On behalf of Whitestone Hospitality Management LLC, Quiddity Engineering LLC has prepared the PD Zoning Application package for the AC Hotel by Marriott development. The 2.66-acre site is currently undeveloped. The application proposes to change from the existing detail site plan to a new detail site plan under the proposed zoning case number PD-221R3R6-HC. A summary of changes from the previously approved detail site plan is shown in the tables below.

The site is located at the northwest corner of the intersection of Interstate 635 and S. Belt Line Road within the city limits of Coppell, Texas.

The detail site plan will include the development of a single hotel, an AC Hotel by Marriott. The Tree Survey/Mitigation Plan is not included, as there are no existing trees on site.
