Reference: Consider approval of Bid number Q-0424-03, contract to Road Master Striping, for the Citywide Restriping Project, in the amount of \$1,000,000.00, as provided for in the General Fund, Fund balance; and authorizing the City Manager to sign any necessary documents.

Introduction:

This memo is provided to consider approval to award a contract to Road Master Striping; for the Citywide Restriping Project; in the amount not to exceed \$1,000,000.00; as provided for in the General Fund, Fund balance.

Background:

The City oversees maintenance for approximately 400 lane miles of pavement, including approximately 40 miles of striping. The city has recently changed lane markings standards from an all raised reflective pavement markers standard to a combination of thermoplastic striping and raised pavement markers. Subsequently, in 2022, a significant striping project commenced, focusing on major city corridors and bike lanes in the amount of \$305,000, which was approximately 10 miles of striping.

Utilizing maintenance funds, efforts have been made to continue these replacements citywide and maintain the new striping. This work typically consists of replacement of thermoplastic pavement markings and raised pavement markers on city streets, intersections, school zones, parking lots and trails. The proposed contract will supplement existing maintenance contracts, aiming to bring the entire city up to current standards and complete the remaining needed roadways, approximately 30 miles of striping.

In April 2024, four bids were received for this project, priced on a "Per Item" basis. Among them, Road Master Striping submitted the lowest bid, ranging from \$1404.85 to \$7435.30. With their experience in similar projects for the City and other municipalities in the metroplex, Road Master Striping stands out as a responsible choice. The thermoplastic striping typically lasts 3-5 years and this contract will have a one-year warranty on the installation. The City's Traffic Division has also purchased a striping machine capable of maintaining the markings when necessary. It is anticipated that it will take a few years to complete the work in this contract and bring the entire city up to the current standard for pavement markings.

This request seeks approval for a contract with Roadmaster Striping, LLC, not to exceed \$1,000,000.00. The contract includes provisions for up to two one-year extensions if deemed beneficial for the city and necessary to complete the work.

Benefit to the Community:

This project will improve the pavement markings throughout Coppell, improve visibility of roadway markings, and overall pedestrian and driver safety.

Legal Review:

The City's standard construction contract has been reviewed by legal periodically, with changes made as requested.

Fiscal Impact:

The fiscal impact of this agenda item is \$1,000,000.00 as included in the assigned fund balance of the General Fund.

Recommendation:

The Public Works Department recommends approval of this item.
