SECTION 2. That the Master Fee Schedule section entitled "Chapter 15, Coppell City Code (Buildings)" be revised to reflect the following:

- 1. formatting changes proposed to separate commercial related fees from residential related fees.
- 2. removed "New Construction" individual fees from the mechanical, electrical, and plumbing because these costs are already included in the comprehensive permit fees for new construction.
- 3. removed the "Temporary Electric" fee since that is an "Electrical Service" permit.
- 4. removed the "Energy Code Inspections" since that is not a service we provide.

SECTION 5. That all provisions of the resolutions of the City of Coppell, Texas, in conflict with the provisions of this Resolution, except as noted herein, be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this Resolution shall remain in full force and effect.

SECTION 6. That should any word, phrase, paragraph, or section of this Resolution be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this Resolution as a whole, or any part or provision thereof other than the part so decided to be unconstitutional, illegal or invalid, and shall not affect the validity of the Resolution as a whole.

SECTION 7. That this Resolution shall become effective immediately from and after its passage as the law and charter in such cases provide.
