A. Consider approval of the Minutes: November 11, 2025 and December 9, 2025.

A motion was made by Councilmember James Walker, seconded by Mayor Pro Tem Don Carroll, that Consent Agenda Items A through D be approved. The motion passed by unanimous vote.

- B.** Consider approval to amend existing agreement with Nema 3 Electric, Inc., to include the installation of additional trail lighting at Wagon Wheel Park in the amount of \$135,178.18 as budgeted in the Coppell Recreation Development Corporation (CRDC) fund, through the City of Coppell's electrical services contract with Nema 3 Electric, Inc.; and authorizing the City Manager to sign any necessary documents.

A motion was made by Councilmember James Walker, seconded by Mayor Pro Tem Don Carroll, that Consent Agenda Items A through D be approved. The motion passed by unanimous vote.

- C.** Consideration of an ordinance for Planned Development - 221 Revision 4 Revised - Light Industrial (PD-221R4R-LI) & Industrial Special District Land Use Plan Amendment, a zoning change request from PD-221R4-HC to PD-221R4R, to allow for the Conceptual Planned Development of a 439,689 square foot Office and Distribution Center and land use plan amendment from Freeway Special District to Industrial Special District, on approximately 25.4 acres located at the southwest corner of Point West Boulevard and Dividend Drive, and authorizing the mayor to sign.

A motion was made by Councilmember James Walker, seconded by Mayor Pro Tem Don Carroll, that Consent Agenda Items A through D be approved. The motion passed by unanimous vote.

- D.** Consider approval to enter into a Professional Services Agreement with Birkhoff, Hendricks & Carter, LLP; for engineering services for the Water and Wastewater System Master Plan Update, and the Water, Wastewater and Roadway Impact Fee Review and Update; in the amount of \$370,600; as provided by the Water/Sewer Fund retained earnings; and authorizing the City Manager to sign any necessary documents.

A motion was made by Councilmember James Walker, seconded by Mayor Pro Tem Don Carroll, that Consent Agenda Items A through D be approved. The motion passed by unanimous vote.

- 9.** Public Hearing: Consider approval of PD-160R2-MF-2, Mansions by the Lake Lot 1, Block 1 (Lakeside Apartments), a zoning amendment to allow conversion of 1,254 square feet of the 2nd floor of the clubhouse building to a residential unit on 34.75 acres of property located along the east side of Coppell Road, approximately 967 feet north of Parkway Boulevard.

Matt Steer, Development Services Administrator, gave a presentation to City Council.

10. City Manager Reports, Project Updates, Future Agendas, and Direction from Work Session

- Coppel Emergency Water Interconnects – The project is complete.
- Magnolia Park – The project is complete.
- Woodridge Channel – The contractor is continuing to install the gabion mattress in front of St. Josephs.
- Dog Park – The contractor has completed all the concrete flat work on the project and continuing to install the sod. They will begin on the synthetic turf areas and the shade structures this week.
- Dart / Silverline – The contractor continues to work on pavement repairs along E. Belt Line.
- Service Center – Staff has moved into the new facility and the contractor is working on demolition on the inside of the older facility to begin the remodel. We plan on hosting an open house on January 26th from 2-3pm. Invitation will come out soon.
- Justice Center – The building interior is continuing. The utilities are complete.
- Bullock and Howell – The contractor has mobilized and is working on Right of Way preparation, trimming trees and will begin on the storm drain.
- Hunterwood Park Bank Stabilization – A pre-construction meeting was held, and the contractor will begin on January 26th.
- Royal Lane Reconstruction – A pre-construction meeting is scheduled for this week. The contractor will begin mobilizing in the coming weeks.
- Coming Soon – a new utility billing payment portal. The City of Coppel is launching a NEW online Utility Billing payment and account management portal designed to expand payment options and improve the overall customer experience. This upgrade supports the City's Vision 2040 Plan's focus on accessibility, service excellence, and modernizing City services. New payment methods include eCheck, autopay using a debit or credit card, and a text-to-pay option. We will guide you every step of the way and share full details before any changes take place.
