

RESOLUTION NO. _____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COPPELL APPOINTING AND RE-AFFIRMATION OF APPOINTMENTS TO THE BOARD OF DIRECTORS OF THE COPPELL CRIME CONTROL AND PREVENTION DISTRICT; PROVIDING FOR STAGGERED TWO-YEAR TERMS IN ACCORDANCE WITH STATE LAW; AND, AUTHORIZING THE MAYOR TO EXECUTE THIS RESOLUTION; AND, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the citizens of the City of Coppel through an election(s) adopted and reaffirmed the creation and funding of a Crime Control and Prevention District; and,

WHEREAS, state law provides that the City Council may appoint City Council members to serve as members of the Board of Directors to serve in staggered two-year terms; and,

WHEREAS, the City Council has adopted an ordinance to establish a seven-member consisting of City Council Members to serve as the Board of Directors of said District; and,

WHEREAS, the City Council has appointed Council Member Places, 1, 3, 5 and 7, to serve as the staggered terms, to expire in even numbered years; and, appointed Council Member Places 2, 4, and 6 to serve staggered terms to expire in odd numbered years; and,

WHEREAS, the City Council desires to appoint, reappoint, and affirm the appointment of its members to serve as the Board of Directors of said District as set forth above; and

IT IS NOW THEREFORE RESOLVED BY THE CITY COUNCIL OF THE CITY OF COPPELL, TEXAS AS FOLLOWS:

SECTION 1. That Council Members in Places 1, 3, 5, and 7 are hereby appointed, reappointed, and/or affirmed to the Board of Directors of the City of Coppel Crime Control and Prevention District for a two-year term, to expire on September 1st, in even number years.

SECTION 2. That Council Members in Places 2, 4, and 6 are hereby appointed, reappointed, and/or affirmed to the Board of Directors of the City of Coppel Crime Control and Prevention District for a two-year term, to expire on September 1st, in odd number years.

SECTION 3. That all members appointed, reappointed, and/or affirmed shall serve as provided herein until terms expire and their successors are appointed and qualified under Texas law.

SECTION 4. That the Mayor is authorized to execute this Resolution upon and after its passage.

SECTION 5. This Resolution shall be effective from and after the date of its enactment as provided by law.
