Regular Session (Open to the Public)

1. Call to Order

The meeting was called to order by Library Board Vice Chair Anne Diamond at 7:01p.m.

Also present were Library Board Members Frank Gasparro, Martha Garber, Seth L. Phillips, Haridas Radhakrishnan, and Radhika Rajgopal Singh; Alternate Board Member Elizabeth Mink; and Youth Advisors Ananya Gogula and Maiya A. Krishna.

Alternate Board Member Manisha N. Pagedar attended via ZOOM.

Library Board Chair Carla Madrigal was absent.

Staff in attendance were Library Manager Alexis Wellborn and Administrative Services Coordinator Laurie Arnold.

2. Citizen's Appearance

This agenda item provides an opportunity for citizens to address the Board or Commission on any matter. 5. Youth Advisor's Report

Youth Advisor Ananya Gogula reviewed the progress of social media projects with the Friends of the Coppel Public Library.

Youth Advisor Maiya A. Krishna discussed ideas to promote ongoing library projects and possibly initiating teen book reviews.

6. Friends of the Coppel Public Library Report

Board Member Frank Gasparro reviewed the upcoming activities for the Friends of the Coppel Public Library.

On October 25, 2025, the Friends will participate in the annual Farmer's Market, Scare on Square, with a mystery book sale and mini pumpkins.

The Annual Big Book Sale, the largest revenue producer for the Friends, is

scheduled for November, 13, 15, and 16, 2025. Volunteers are needed.

The Friends are discussing ways to promote membership when library cards are issued. The next Friends meeting is September 22, 2025.
