A RESOLUTION OF THE CITY OF COPPELL, TEXAS, ORDERING CANCELLATION OF THE GENERAL ELECTION ON MAY 9, 2015, AND DECLARING THE ELECTION OF UNOPPOSED CANDIDATES FOR MAYOR, PLACE 2, PLACE 4, AND PLACE 6 OF THE CITY COUNCIL OF THE CITY OF COPPELL, TEXAS; PROVIDING FOR THE ISSUANCE OF THE CERTIFICATES OF ELECTION; PROVIDING FOR THE POSTING OF THIS RESOLUTION AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, by Resolution No. 2015-0127.1, the City Council called for an election on May 9, 2015, to elect a Mayor, and Council Members for Places 2, 4, and 6; and,

WHEREAS, the time for filing as a candidate for the May 9, 2015, City Council election has passed; and,

WHEREAS, Subchapter C, Election of Unopposed Candidate of the Election Code provides that a municipality may cancel an election for council members if each candidate whose name is to appear on the ballot is unopposed and no proposition or special election has been called to appear; and,

WHEREAS, as required by law, the City Secretary has delivered a written certification to the City Council certifying that the candidates for election for a Mayor, and Council Members for Places 2, 4, and 6 are unopposed; and,

WHEREAS, that in accordance with the Texas Election Code, City Council desires to cancel such election and declare the unopposed candidates elected to office.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF COPPELL, TEXAS:

Section 1. That the election called for May 9, 2015, to elect a Mayor and Council Members for Places 2, 4, and 6 is cancelled.

Section 2. That the following unopposed candidates have been certified as unopposed and are declared elected:

Section 3. That a copy of this Resolution will be posted on Election Day at each polling place that would have been used in the election, as required by the Election Code.

Section 4. That a certification of election will be issued to each candidate in the same manner and at the same time as provided for a candidate elected at the election, as required by the Election Code.

AND IT IS SO RESOLVED AND ORDERED.
