Scope	Cost
1. Demolition, Removal and Disposal of the existing deck (1,000 SF)	\$3,000
Saw cut various areas of pool deck to create straight line joints	
Demo various areas of pool deck where concrete is cracked or damaged	
2. Itemized cost detail of repair of concrete (1,000 SF)	\$8,200
Pour 4 inch broom finished concrete in areas that have been removed	
- Concrete is rated at approximately 3000 PSI.	
- Install #3 rebar on 18 inch centers	
- Dowell into existing adjacent concrete to help prevent differential settlement	
- Add polypropylene fibers in the concrete mix to strengthen concrete and helps control cracking	
3. Itemized cost detail of replacement of drains (20 Drains)	\$750
Remove and replace all metal 12 inch x 12 inch drain grates on pool deck	
4. New Deck Material per unit cost (21,775 SF)	\$161,716
5. Installation Labor for new deck per unit cost (21,775 SF)	\$27,000
Prepare surface using a walk behind grinder to remove existing damaged cool deck material	
- When grinding any surface, it is possible to discover more concrete that needs to repaired	
Power wash surface to start with a clean base	
Hand troweled bond coat applied to new and existing concrete	
Install Carvestone on top of bond coat.	
Surface is textured by hand with a sponge	
Pattern is created by Carving out each stone in the material by hand	
2 custom CORE graphics included	
Colors will be chosen using a sample board we create onsite	
Install a complementary color of Carvestone as grout between stone pattern	
Roll on a solvent based sealer with a non skid additive	
Apply a layer of mastic in all joints of pool deck	
Areas to be Overlayed - total of 21,775 square feet	
- pool deck, steps with vertical areas and coping around all 3 pools	
6. Rental equipment costs (3 days)	\$3,000
Rent a walk behind grinder calles a scarifier to help remove existing Sundeck material	
7. Extended warranties if applicable	
Warranty will 2 years (this is 1 additional year more than conventional commercial warranty)	
We are proud to offer you a seven year (residential) and one year (commercial) limited warranty that covers the bond between the Carvestone and your underlying surface. The warranty protects against chipping and delamination of your Carvestone from the substrate. The warranty does not cover cracking, color or sealer loss, or mastic failure. We confidently warrant against chipping and delamination because Carvestone is exceptionally durable and not particularly susceptible to these problems often seen in other overlays on the market. This warranty expresses that confidence.	
8. Pool work	\$5,593
Damaged skimmers are in areas where concrete will need to replaced	
Replace 1 set of pool numbers that area damaged near large pool
