## RESOLUTION NO.

A RESOLUTION OF THE CITY OF COPPELL, TEXAS, AMENDING, THE MASTER FEE SCHEDULE, BY REPEALING "CHAPTER 15 COPPELL CITY CODE (BUILDINGS)", SECTION 6 "ADDITIONS, ALTERATIONS, **REPAIRS AND DEMOLITIONS" AND REPLACING IT WITH NEW** SECTION 6 **"ADDITIONS, ALTERATIONS**, REPAIRS AND DEMOLITION FOR NON-RESIDENTIAL" AND BY ADDING A NEW SECTION 6A TO ESTABLISH RESIDENTIAL FEES; AND BY AMENDING CHAPTER 15, "COPPELL CITY CODE (BUILDINGS)" BY AMENDING SECTION 12 'MISCELLANEOUS FEES' BY ADDING ADDITIONAL FEES; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** the City of Coppell, Texas, provides for general and special fees and charges to be assessed and collected by the City, as authorized by the Code of Ordinances and other applicable codes, ordinances, resolutions, and laws; and

**WHEREAS,** the City Council of the City of Coppell desires to amend their Master Fee Schedule to establish Non-Residential and Residential permit fees.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COPPELL, TEXAS:

**SECTION 1.** That the section of the Master Fee Schedule entitled "Chapter 15, Coppell City Code (Buildings)", be amended, by repealing Section 6 "Additions, Alterations, Repairs and Demolition" and replacing it with a new Section 6 "Additions, Alterations, Repairs and Demolition for Non-Residential" to establish non-residential fees and by adding a new Section 6A to establish residential fees, which shall read as follows:
