HISTORY:	In April of 2003 the property was rezoned to allow the development of the college campus. At that time approximately 10 acres was developed, containing the existing campus building and associated parking. In 2011 the PD was amended to allow a gas valve site to support the gas pipeline installed parallel to SH 121.	
HISTORIC COMMENT:	This property does not have any historic significance.	
TRANSPORTATION:	State Highway 121, is a state highway, recently built to standard. Sandy Lake Road is a four-lane divided thoroughfare in a six-lane R.O.W. Royal Lane is a four-lane divided thoroughfare in a six-lane R.O.W.
