As authorized by Section 551.071(2) of the Texas Government Code, this meeting was convened into closed Executive Session for the purpose of seeking confidential legal advice from the City Attorney on any agenda item listed herin.

Vice Chairman Portman called the meeting to order at 6:00 p.m.

Discussion regarding agenda items.

The Planning & Zoning Commission was briefed on each posted agenda item, no vote was taken on any item discussed.

6:30 p.m. Regular Session (Open to the Public)

1. Call to order.

Vice Chairman Portman called the Regular Session to order at 6:54 p.m.

2. Consider approval of the minutes for July 18, 2019.

A motion was made by Chairman Robinson, seconded by Commissioner Walker, to appove the minutes as written. The motion passed unanimously, (5-0).

Consider approval of an Ordinance for PD-240R6R-HC, Hat Creek Burger Company, a zoning change request from PD-240R6-HC (Planned Development-240-Revision 6-Highway Commercial) to PD-240R6R-HC (Planned Development-240-Revision 6-Revised-Highway Commercial) to allow a restaurant (approx. 1900-sf) with a drive-through, patio (approx. 1100-sf) and play area to be constructed on approximately 0.81 acres, at the northwest quadrant of SH 121 and Denton Tap Road, further identified as Lot 4, Block A, of the North Gateway Plaza Addition; and authorizing the Mayor to sign.

Mary Paron-Boswell, Senior Planner, presented the case with exhibits. Ms. Paron-Boswell stated that staff is recommending APPROVAL of PD-240R6R-HC, Hat Creek Burger Company, subject to the following conditions:

- 1. Additional comments will be generated at the time of Detail Engineering review.
- 2. Approval of the variance to the signage request for 74 square feet,
- 3. All signs must meet sign ordinance requirements relating to material and lighting.
- 4. Revise the elevation sheets to accurately reflect the signage.

Vice Chairman Portman opened the Public Hearing. Seeing that no one wished to speak, Vice Chairman Portman closed the public meeting.

Clay Christy, Claymoore Engineering, 1903 Central Drive, Bedford, TX 76201, was present to answer any questions of the Commission. Mr. Christy stated he was in agreement with conditions recommended by staff.

A motion was made by Chairman Robinson, seconded by Vice Chairman Portman, to recommend approval of this agenda item with the conditions outlined by staff. The motion passed unanimously, (5-0).
