Consider approval of the May 5, 2022, Board of Adjustment, as the Board of Appeals, meeting minutes.

Consider approval of a variance request from City Ordinance Article 35, Section 12-35-2, B.2(a) to have a carport in the back yard of the property closer to the rear property line than the ten foot (10') setback required by ordinance (structure will be approximately six feet ten inches (6'10") from the rear property line), located at 337 Park Meadow Way, as requested by owner Robert H. Hunnicutt.

All participants attending the Public Hearing in person and wishing to speak before the Board of Adjustment were sworn-in to present testimony by Vice Chair, Michelle Anderson.

Applicant and homeowner, Bob Hunnicut, 337 Park Meadow Way, Coppell, TX 75019, presented his testimony.
